Top 5 Covenant Enforcement Issues

- 1. **Trash Cans** Trash stored outside must be kept in closed metal or hard plastic containers behind solid fencing so that it is not visible to the public/street.
- Weeds in Landscape- Repair/treat insect, fungus issues, or winter damage to lawn; remove and replace dead grass with the types of sod allowed by the Architectural Control Guidelines for Watermill Master Section 4.03
- Maintenance of Mailboxes and Post- Maintain mailbox and post to avoid unsightliness due to normal weathering. Mailbox Specifications are listed within the Architectural Control Guidelines for Watermill Master. - 4. **Pressure Washing** Maintenance of the home exterior, maintain all exterior surfaces of the home including eaves, soffits, fascia, gutters, roof and body of the home clean of stains and mildew and painted on a regular basis.
- 5. **Maintenance of Fencing** Maintain fencing, including any gates, retain a neat appearance; free of stains and mildew. Replace broken slats or posts promptly.
