## BASKETBALL COURT RULES

**“NO TRESPASSING” – PRIVATE FACILITY – MEMBERS ONLY**  
**OF THE**  
**“WATERMILL MASTER ASSOCIATION, INC.”**

**“BEFORE USING THE COURT, ALL MEMBERS MUST REGISTER WITH THE ATTENDANT OR GUARD WHEN THEY ARE ON DUTY. YOU MUST BE A MEMBER OF WATERMILL TO USE THE COURT”**

**“GUEST LIMITED 3” (PER HOUSEHOLD)**

**AN ADULT MEMBER (18 OR OLDER) MUST ACCOMPANY ALL GUEST AT ALL TIMES**

**GUEST POLICY: THE MEMBER AND ALL GUEST ARE REQUIRED TO SHOW A PICTURE I.D. WITH THE ACCESS CARD. MEMBER CARDS ARE HELD AT THE OFFICE AND RETURNED WHEN PLAY IS COMPLETE.**

**CHILDREN 11 AND UNDER MUST BE ACCOMPANIED BY AN ADULT MEMBER AT ALL TIMES (18 YEARS OR OLDER)**

**“ONLY 12 PLAYERS” ALLOWED ON THE COURT AT ONE TIME**

**COURT TIME ONE HOUR PER GROUP OCCUPYING THE COURT – NO CONTINUOUS SAME GROUP PLAY IF OTHERS ARE WAITING**

**COURT TIME - BY RESERVATION ONLY – MAXIMUM ONE HOUR PLAY PER MEMBER & GUEST**

**PLAY AT YOUR OWN RISK**

**NO FOUL OR OBSCENE LANGUAGE**

**NO SMOKING / NO ALCOHOLIC BEVERAGES**

**NO SKATEBOARDS, ROLLER SKATES, ROLLER BLADES, BIKES ETC. ON THE COURT OR WITHIN THE FACILITY**

**NO GLASS CONTAINERS**

**NO TRASH LEFT ON THE COURT**

**NO PETS**

**NO LOUD MUSIC**

**ANY MEMBER ALLOWING NON-MEMBERS OR UNREGISTERED GUEST ACCESS TO THE COURT IS IN VIOLATION OF THE COURT RULES AND SUBJECT TO IMMEDIATE SUSPENSION OF PRIVILEGES!!**

**THE SECURITY OFFICER AND THE POOL MONITOR HAVE COMPLETE AUTHORITY TO OVERSEE AND ENFORCE THE RULES AND REGULATIONS OF THE FACILITY. LOUD, OBSCENE, RUDE OR OBNOXIOUS LANGUAGE OR BEHAVIOR IS NOT TOLERATED.**

**FAILURE TO COMPLY WITH THE RULES OF THE COURT MAY RESULT IN SUSPENSION OF MEMBERSHIP PRIVILEGES.**
