THIS RESOLUTION of the Board of Directors of Watermill Master Association, Inc., a Florida Not for Profit Corporation (the "Association") is made this // day of September, 2018.

## **RECITALS:**

- A. The Declaration of Covenants, Conditions, Restrictions and Easements for Watermill is recorded at Official Records Book 9927, page 1781, et seq., of the Public Records of Duval County, Florida, and is hereafter referred to as the "Declaration".
- B. Article 7 of the Declaration sets forth the obligation of each Owner to timely pay their regular and special assessments.
- C. Section 7.8 of the Declaration provides that the Board of Directors may impose a penalty on an account which is delinquent more than 15 days, which may include the imposition of a late charge and interest.
- D. The Board of Directors desires to establish a policy to delay the imposition of a late charge and interest on a delinquent account for those certain Owners who have experienced a temporary hardship in their ability to make a timely payment of their account.

NOW, THEREFORE, in consideration of the premises, the Association hereby gives notice of the following policy of imposing late penalties on a delinquent account, set forth as follows:

- 1. The Board of Directors may impose to an Owner's account which is delinquent more than 15 days a late fee in the amount of \$25.00 and impose interest at the maximum rate allowed by law, EXCEPT that the Board of Directors may, at its sole discretion, provide for a period of up to ninety (90) days from when the assessment first came due before late fees or interest are imposed on the delinquent account in the following events:
  - a. Verified hospitalization of the Owner;
  - b. Verified incapacity or death of the Owner;
  - c. If the Owner is currently deployed under military deployment orders; or,
