Why do we need an HOA anyway? The various states initiated them, many years ago, to have someone responsible (\$\$\$) for the storm water runoff collection systems. HOAs are not the swim club, nor do they fill in for the county government or police when things do not get done. Good ones do maintain the community assets, improve them where and when possible, to maintain property values in the community.

Covenant and restriction enforcement: Approximately 3,850 violation letters have been sent so far this year. The number of violations has increased directly in proportion to the number of rentals. The Board has been hamstrung in enforcement of the regulations by state statutes and our own covenants. We have found legal "work arounds" to speed up the process. These changes will be voted in at the next board meeting. Procedures will take days instead of weeks and fines will be more of a deterrent in 2022. One out of four homes in Duval County are corporate owned.

Watermill Master Association App: Go to your smartphone app store and put in Watermill Master Association and download. You will be able to review the HOA calendar and documents as well as receive notifications from your phone or tablet.

Snakes: Reports have come in of venomous snake sittings around the amenity center area. There is no need to panic. Just keep your eyes open. This is their matting season and love makes them do crazy things.

Trash pickup: We are all frustrated by the way city hall fumbled the ball on this issue. At this point, recycle pickup is suspended and you can use your recycle can for household waste. You can take your recycle to the designated stations (lose, not in bags) or mix it with your household trash. Yard waste will supposably, eventually, be picked up.
